
Abstract

In this paper I have investigated enterprise level factors affecting access to formal credit for small enterprises in India by employing probit model. The results indicate that the owners education level, North-west region are positively associated with access to formal credit. Enterprises in eastern region and a female owner of an enterprise are more likely or vulnerable to face credit constraint. These results provides some insights into the factors to improve credit constrained for small enterprises in India.
