

ABSTRACT

This study looks at a long run cointegration analysis of strategy variables among six major firms in the Indian steel industry. The objective is to check for convergence of strategies based upon the long run values of certain key defined variables. Preliminary diagnostic checks for stationarity and unit roots are performed. Panel cointegration analysis is then used to check for convergence at higher levels for the strategy variables.
