

Abstract

This paper investigates tax competition between different countries in a dynamic framework, where the stock of capital adjusts to the tax rates adopted by different countries. More specifically, the model compares the Nash equilibria tax rates that emerge under the assumptions of “closed loop” and “open loop” competition. The resulting equilibrium rates of tax are different and therefore the policy conclusions are also different.
