

ABSTRACT

This paper aims at studying the existence of herding behavior in an emerging stock market like that of India. The state space model has been employed for this study which yields consistent and significant results evidential of the existence of herding behavior in the Indian stock market. While the simple model using cross sectional standard deviation of betas yield significant results, the robustness of the results are studied by conditioning on market return and volatility.
